



## Genuine Temporary Entrant Requirement (GTE) Form

Genuine student is someone who has real intentions to study only and who intends to obtain an education degree from an Australian education provider. Factors that are considered under the existing requirement to be a genuine applicant for entry and study as a student include: English language proficiency, financial capacity, prerequisite schooling. Age requirements, and intention to comply with visa conditions.

Students are requested to provide a statement or/and answer the following parameters in the application to satisfy the requirement of following criteria of GTE:

- The applicant's circumstances in their home country
- The applicant's potential circumstances in Australia
- The value of the course to the applicant's future
- The applicant's immigration history
- Any other relevant matters

Applicant personal statement must be in English addressing the GTE requirement. Where an applicant is not comfortable writing their statement in English, it can be written in their own language, however, a translated copy must be submitted. An applicant can provide details within the application form, or attach a written statement along with supporting documents. Generic statements unsupported by evidence will not be weighed heavily in the GTE assessment. <https://immi.homeaffairs.gov.au/visas/getting-a-visa/visa-listing/student-500/genuine-temporary-entrant>

Note: The agent must risk assess an applicant. Decision makers may request additional information and/or further evidence from the applicant to demonstrate that they are a genuine temporary entrant.

- Applicant has done adequate research on Lead College Pty Ltd courses, support services, facilities and locations.
- Applicant has demonstrated a clear understanding of the benefits of undertaking their chosen study pathway at LEAD.
- Applicant has strong family support.
- Applicant has a clear understanding of the Australian Student Visa conditions including GTE
- Applicant has a confirmed source of funding and contingencies in place should their source of funding suddenly.
- Supporting documentation has been sighted and is available upon request.
- Applicant has realistic expectations of all costs for the duration of their studies
